

Food Grade -

Dawn Food uses mutliwall bags that meet regulatory standards for use of food packaging. The composition includes natural and bleach paper, film and adhesives. Our supplier uses all US FDA certified components in the finished packaging product.

<u>SDS -</u>

It is our opinion that "Safety Data Sheets" (SDS) are not required for our Dawn Products based on the definition of "Chemical Hazard" as defined in OSHA "Hazard Communication" Rule, 29 CFR 1910.1200. Dawn Products as food items are best protected when stored according to product specifications.
