Rich Fudge icing / Suntuosa cobertura de fudge 4 lb 4 oz Fudge icing Base / Base de fudge para coberturas 16 lb 10 oz Powdered Sugar / Azúcar pulverizada 3 lb 2 oz Hot Water (Variable) / Agua callente (variable) 1 lb

Corn Syrup / Jarabede maíz

Add sugar to fudge icing base and cream on low speed. Then add 1 lb 10 oz of water and continue blending on low speed while adding corn syrup and remaining water. Mix well. Añada azúcar a la base para fudge para coberturas y bata a velocidad baja hasta que tenga consistencia cremosa. Añada 1 lb 10 oz de agua y siga batiendo a velocidad baja mientras añade el jarabe de maíz y el resto del agua. Mezcle bien.

Add all dry Ingredients and mix thoroughly.

Add water slowly until desired consistency is obtained.

Microbiological limits are monitored and are not tested on each batch manufactured.


Food Grade
