It has preservative properties, and is used in jams, marmalades, gels and fruit pastes to optimize the gelling of pectins. It is also used to reduce the darkening of fruits and vegetables, provide acidity, to make invert sugar, and so on.

It is usually used diluted in water or introduced directly into the preparation.
